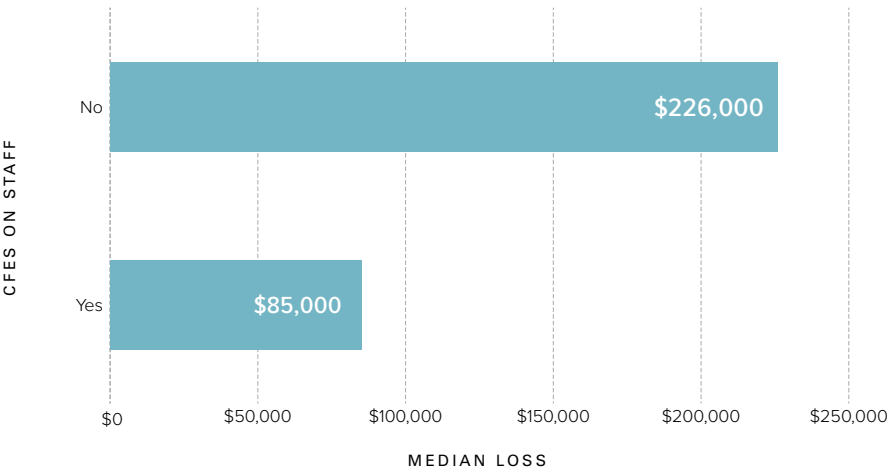
CFEs PROTECT ORGANIZATIONS

CFEs possess expertise in preventing, detecting and investigating fraud, and this proactive approach reduces the duration and median loss of a fraud. ACFE research shows that organizations with CFEs on staff uncover frauds 50% sooner and suffer losses 65% lower than organizations without CFEs.

Become a CFE in 4 Steps:



STEP 1

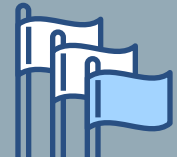
